

FANDANGO'S COMEDY SWEEPSTAKES ("Sweepstakes")
OFFICIAL RULES ("Official Rules")

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

YOU MUST BE 21 YEARS OF AGE OR OLDER TO WIN THE GRAND PRIZE. IF YOU BRING A GUEST, THE GUEST MUST ALSO BE 21 YEARS OF AGE OR OLDER.

The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of Fandango Media, LLC ("Sponsor"), which are binding and final on matters relating to this Sweepstakes.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. By submitting a Sweepstakes Entry, you agree to these Official Rules and are willing provide your information to the Sponsor and the Administrator. Sweepstakes Entries become the property of the Sponsor and will not be returned.

SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION: Winner is subject to verification of eligibility requirements, including verification of age. The potential winner of the Grand Prize (defined below) is referred to herein as the “Winner”.

Sponsor is not responsible for any cancellations, delays, diversions, or substitutions, or any act or omission whatsoever with respect to any Grand Prize.

Odds of winning will depend on the number of qualified Sweepstakes Entries received during the Sweepstakes Period.

GRAND PRIZE (1): There is one (1) grand prize ("Grand Prize") available to be awarded to one (1) Winner. Winner will receive a four (4) day, three (3) night trip for Winner and one (1) guest ("Guest") to Las Vegas, NV or New York, NY (Winner may choose either city) . Should any portion of the Sweepstakes be, in the Sponsor's sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play or submission of Sweepstakes Entries, the Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Sweepstakes. If terminated, at its discretion, the Sponsor reserves the right to select the potential Winner from all eligible, non-suspect Grand Prize claims received prior to action taken or as otherwise deemed fair and appropriate by the Sponsor. In no event will the Released Parties be liable for more than the stated number of prizes in these Official Rules. arbitration rules of the American Arbitration Association, in Los Angeles County, California. Any such controversy or claim shall be arbitrated on an individual basis and shall not be consolidated in any arbitration with any claim or controversy of any other party.

CHOICE OF LAW AND JURISDICTION: All federal, state, and local laws and regulations apply. Void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of California without giving effect to any choice of law or conflict of laws rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules not subject to arbitration shall be brought only in the courts of the State of California, in the County of Los Angeles. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-conveniens or lack of personal jurisdiction.
